Hope this letter finds you all well.

We are getting busy with plans for the 2025 Keepataw Fun Fest Artisan Market which will take place on Sunday, August 31, 2025 from 2pm-7pm. This year's theme is "NEIGHBORS HELPING NEIGHBORS"

What we are offering:

1. You will have 2 full parking spots, 18 feet wide by 20 feet deep.
2. There will be 3 feet in between each booth to allow your customers to shop.
3. Unfortunately, we will not be able to supply power, tents/canopies, or weights. The Village of Lemont does require that all tents/canopies are weighted at each corner with a minimum of 20 lb. weights. If you do not have weights, you will be asked to get them, or be removed from the show.
4. Lemont Keepataw Day is not responsible for lost or stolen items.

The Artisan fee structure:

1. Paid between December 15, 2024-June 1, 2025 \$50.00
2. Paid between June 2, 2025- July 1, 2025 \$75.00
3. After July 15, 2025 your name will be removed from our vendor list if we have not received application and payment.
4. We will accept Artisans on a waiting list.
5. No refunds of show fees for cancellations within 30 days of the event.
6. Booth spaces are non-transferrable and cannot be shared with another Artisan without prior approval.
7. Booth spaces are reserved on a first come first served basis.

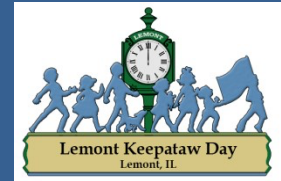
